

Event Contract

Promoter: BIJOU BASH

Event: Sugarplum Fall Festival Space

Cost: \$100

Premium upgrades available for \$25-\$50

VENDOR REQUIREMENTS

Vendors must only bring items to sell that have been listed on their application and approved by BIJOU BASH.

Vendors must have booth set no later than 10:30AM or vendor may be removed from the event without refund. Vendors may not strike their booth ANY EARLIER than 2:30pm and are responsible for leaving the area in the same condition it was found. Vendors who violate these terms will not be invited back to participate in any future events.

PAYMENT

Payment is due upon receipt of invoice unless otherwise specified. Vendor space will not be reserved without receipt of payment. If vendor should cancel less than one week prior to the event date, payment is non-refundable as all funding goes toward organizing, marketing and advertising the event. If vendor should request to reschedule less than one week prior to the event date, a fee of \$50 will be charged to attend a future BIJOU BASH event of equal value. For full refund, vendor must cancel more than 30 days prior to the event date. No refunds will be issued due to lack of sales, or competing vendors.

CANCELLATION

In the event that BIJOU BASH should cancel due to unforeseen circumstances (including but not limited to weather conditions and cancellations by third party promoter i.e. venue or partner), the vendor payment may be used as a credit toward a rescheduled date or another BIJOU BASH event. No refunds.

SHARING OR SUBLEASING

Vendors may not share or sublease their space without approval; this includes renting, sharing, donating or in any other way allowing for another company or person to display or advertise in their paid space. Vendors caught sharing or subleasing will be expected to pay double the rate for their space (e.g. if sharing, both companies pay the same rate) on the day of the event. Failure to pay will result in immediate removal from the event.

ADMISSABLE BOOTHS

Vendors that are disruptive or inappropriate in nature, as interpreted by

BIJOU BASH, will be removed from the Event without refund. Consumable food products or beverages are not permitted without consent from promoter. Sample item(s) may be confiscated unless previously approved. Any food items confiscated during the Event will be returned at close of event. Perishable items are not the responsibility of BIJOU BASH under any conditions.

INSURANCE

BIJOU BASH shall not be responsible for any injuries to persons and/or any damage or loss of property for any reason, including theft, unless such loss of property is caused by negligence of Promoter. Vendor is required to follow and use any of the security arrangements by Promoter for property and valuables. The Vendor is solely responsible for personal property. Vendor is required to provide internal staffing to watch and maintain all booth property (e.g. Merchandise, Display Units, Promotional Collateral)

The Vendor Agreement shall become binding upon the parties only upon (1) BIJOU BASH sending you an invite and (2) your acceptance of THE BIJOU BASH Vendor Agreement by paying the Booth Rental Fee in accordance with the invite email (the Binding Conditions.)
